Depending on the rotation requested, practicum students may have 1-2 groups and/or complete 3-6 testing batteries over the course of the training year. Participation in psychodiagnostic rotation will be based on a good match between level of experience and cases available, the trainee's competence, demonstration of adequate competency/ability to complete assigned clinical duties prior to adding rotation, and the discretion of the Practicum Training Coordinator. All trainees who participate in this rotation are required to have completed all assessment coursework at their universities, and to submit a de-identified report as part of their application.

What specific (perhaps unique) training opportunities do students have as a practicum student at your agency?

The Help Group is one of the largest providers of mental health services to children and families in LA County. Practicum students can see clients in outpatient, after-school day treatment (REACH), or school-based (if they have obtained a master's degree and are eligible to be registered as a psychological assistant with the Board of Psychology) settings. The specificity of each school-based program allows students to concentrate on specific diagnoses and problem presentation (i.e., autism, learning disabilities, emotional disturbance), or they can have a fuller range of diagnoses through the outpatient department. It should be noted that students providing treatment in the outpatient department will be expected to deliver some field-based services (i.e. in-home or community-based services). In the school-based and after-school day treatment program, there is a very strong emphasis on milieu treatment and a strong team approach to treatment. The Help Group also uniquely offers opportunities for practicum students to engage in elective rotations, including psychological assessment, group therapy, and/or program development. As the practicum training program is modeled after the APA accredited internship at The Help Group, students are also exposed to a variety of training which includes co-leading groups with interns and participating in agency-wide trainings.

What theoretical orientations or specific treatment modalities will students be exposed to at this site?

We conceptualize from cognitive-behavioral, behavioral, psychodynamic, and systems perspectives, with a strong emphasis on diversity and socio-cultural aspects of the client and family.

Do students have the opportunity to work in a multidisciplinary team environment? If so, please list the non-psychology professionals/paraprofessionals who work as a part of your staff.

Psychologists, Psychiatrists, social workers, MFT's, speech therapists, occupational

therapists, teacher's assistants, and school principals are all part of our team. The practicum students who work in the school and/or after-school day treatment programs will gain extensive experience in those milieu settings.
